集成金融(03623.HK) -0.010 (0.364%) 就與內地一家分保公司訂立的合作協議作進一步公布，根據協議，分保公司在與集成擔保合作議期內承擔擔保責任，包括任何新擔保業務，以及到期日不少於合作協議生效日期後3個月的現有擔保。

擔保業務類型包括貸款擔保、票據承兌擔保、貿易融資擔保、項目融資擔保、信用證擔保及其他融資性擔保業務；貸款期限不超過一年，每項擔保合約金額不超過2000萬元人民幣(下同)；賠償比例不超過1000萬元；合作於本月15日計起，為期一年，可自動延期一年。(ch/u)

C SUCCESS FIN (03623.HK) -0.010 (0.364%) announced Success Guarantee, a subsidiary of C SUCCESS FIN, entered into a cooperation agreement with the re-guarantor relating to the proportional re-guarantee. The re-guarantor agreed to provide the proportional re-guarantee to Success Guarantee in respect of the following guarantee businesses of Success Guarantee: (a) the guarantee business which Success Guarantee undertakes guarantee obligations during the agreement term, including (i) any new guarantee business entered into between Success Guarantee and its customer during the agreement term; and (ii) any guarantee business which subsists before the date of the cooperation agreement which is not overdue and with maturity date of no less than three months after the effective date of the cooperation agreement.

《經濟通通訊社29日專訊》集成金融（03623）表示，為減低其主要營運附屬公司集成擔保的風險承擔，集成擔保與中國一家分保公司中合中小企業融資擔保訂立合作協議，據此，該分保公司同意擔保集成擔保的全部或部分擔保責任。

根據協議，若集成擔保於一項擔保合約項下的擔保金額不超過1000萬元（人民幣，下同），則分保人同意賠償集成擔保向貸款機構所作賠償的20%；若集成擔保於一項擔保合約項下的擔保金額超過1000萬元但不超過2000萬元，則分保人同意賠償集成擔保向貸款機構所作賠償的10%。

集成擔保主要向客戶提供融資擔保，協助其取得銀行或其他機構的貸款。倘集成擔保的客戶違約或未能於到期日前償還任何未償還貸款額，集成擔保將有責任須於按貸款機構與集成擔保所訂立的擔保合約規定發出賠償通知後的一段時間內就拖欠款項向貸款機構作出賠償。（p1）

<匯港通訊> 集成金融(03623)宣布，集團與中合中小企業融資擔保(分保人)就比例分保訂立合作協議，就商定業務而言，倘集團根據所訂立的擔保合約為其客戶向貸款機構作出賠償，分保人同意就集團支付的款項根據賠償比例向集團作出賠償，分保人就單一客戶於一項或多項擔保合約下的應佔違約款應向集團支付的賠償總額不會超過200萬元人民幣。合作協議自本月15日起計為期一年，可延期一年。

集成金融指，經考慮合作協議的條款及參考集團的現有分保協議，以及為進一步降低集團的現有風險，認為合作協議的條款屬公平合理，並符合公司股東的整體利益。

(Infocast News) China Success Finance Group Holdings Limited (03623) announced that its principal operating subsidiary, Guangdong Success Finance Guarantee Company Limited (Success Guarantee), has entered into a cooperation agreement with China United SME Guarantee Corporation (re-guarantor) relating to a proportional re-guarantee.

In respect of guarantee businesses of Success Guarantee, if Success Guarantee indemnified the lending institution for its customers pursuant to the guarantee contract between the lending institution and Success Guarantee, the re-guarantor agreed to proportionally compensate Success Guarantee for the amount paid by Success Guarantee according to the compensation percentage.

The aggregate compensation payable by the re-guarantor to Success Guarantee in respect of the defaults attributable to one single customer under one or several guarantee contract(s) will not be more than RMB2 million. The term of the cooperation agreement is one year commencing from 15 November 2013, which could be automatically extended for one year.
